Scholarship and Financial Assistance Policy for MBBS & BDS

Musabiqat Scholarship:

Top three position holders of 1st annual exam of respective prof of Riphah International University for MBBS & BDS degree programs are eligible for this scholarship.

Usra Assistanceship (Kinship Concession):

Usra assistantship is awarded to real brother(s)/sister(s) of those students studying in any program of Riphah International University and paying fee simultaneously for same term.

1. It is awarded to brother(s)/sister(s) admitted later.
2. 10% assistance ship on tuition fee is available to 2nd brother/sister, 20% of tuition fee to third brother/sister.

Wali Assistanceship (Orphanage scholarship):

Assistance ships under this scheme are available to students whose sponsoring parent is deceased after admission to Riphah International University. 50% assistantship on annual tuition fee is awarded for respective term to MBBS & BDS students. For continuation of assistance ship student must pass his/her final prof in 1st annual examination.

Mawakhat Assistanceship (Need cum based assistance):

Need cum merit base financial assistance is awarded to deserving students whose financial position is adversely affected due to an un-expected severe incident caused after his/her admission to Riphah International University. A four-member committee decides the number and value of financial assistance subject to below requirements.

1. The student must prove his/her hardship to the competent authority.
2. The assistantship is awarded on tuition fee of respective term.
3. For continuation of assistance ship student must pass his/her final prof in 1st annual examination.

Assistanceship for Nominees of Al-Mizan Foundation:

One assistance ship is available in MBBS as per agreement of IIMC-T and Al-Mizan Foundation. Student must meet merit requirement for admission to MBBS and possess nomination from Secretary Al-Mizan Foundation in writing. Student is awarded 100% assistance ship on Tuition & Admission fee. For continuation of assistance ship student must pass his/her final prof in 1st annual examination.

Assistanceship for Nominees of Pakistan Railways

Three assistance ships are available in MBBS as per agreement of IIMCT and Pakistan Railways. Student must meet merit requirement for admission to MBBS and possess nomination from Pakistan Railways Headquarter Lahore in writing. Student is awarded 50% assistance ship on Tuition & Admission fee. For continuation of assistance ship student must pass his/her final prof in 1st annual examination.

General Rules for Scholarships / Financial Assistance:

1. Mentioned scholarships/assistanceship are available only to eligible students of Islamic International Medical College and Islamic International Dental College.
2. To be considered for award of scholarship/assistance ship there should be no dues outstanding for preceding terms against the respective student applying for scholarship/assistance ship.
3. Each Riphah Student is eligible for the award of scholarship/assistance ship in one scheme.
4. Scholarship/Assistance ship is not applicable to courses/semester/terms repeated by the student.
5. Students of 1st. term & students admitted on special/reserved seats are not eligible for assistance ship under “Mawakhat” scheme.
6. Once FA Committee has given any decision it cannot be reviewed or reconsidered in that particular term.
7. University has the discretion to revise its rules and regulations as deemed necessary by the authorities from time to time.

Application for Financial Assistance:

1. A student seeking financial assistance must apply for on a prescribed application form. Forms are available in Finance Department
2. Applications for financial assistance are entertained if submitted within the first two weeks of commencement of classes or with in due date payment of fee for respective term.
3. Applications must be signed by the parents/guardian of student enclosed with reliable evidence of financial constraints & academic performance.
4. The concerned student is communicated about the outcome of their applications in due course of time. In case assistance ship is approved remaining amount must be deposited within fifteen days.
